Election Day registration is offered for the Primary, General, Municipal, and county-wide elections. However, registration prior to the election is recommended. To register, one must be a U.S. Citizen, 18 years old on election day, and a bonafide state and county resident (30-day residency required). All cities have city-county joint registration. You must re-register if you move, have a name change, or if you fail to vote during a four-year period. You may re-register at the polls on election day by providing proper identification, but you will save time and trouble by pre-registering. You may obtain mail-in registration forms in your county's driver's license, health and welfare departments, and other State agencies. Registration will close 25 days prior to the election. If you have any questions call the County Clerk at (208) 799-3020.**ELECTION DAY INFORMATION**

Notice of an election will be published in the legal section of one newspaper in the county at least twice. Each notice will provide the date of election, polling place in each precinct, and the hours polls shall remain open for voting.

GENERAL ELECTION Nov. 2, 2010**ABSENTEE VOTING**

Application for an absentee ballot: (you must be registered to vote in Idaho to request an absentee ballot). If you wish to have an absentee ballot mailed to you, the request must be received by the county clerk's office by the 6th day prior to the election. You can still cast an absentee ballot in person at the absent elector's polling place (usually the county clerk's office) up until 5 p.m. the day before the election. The County Courthouse is the polling place for all absentee voting for city, county, state and federal elections. Written requests are to be mailed to: Election Officer, P.O. Box 896, Lewiston, Idaho, 83501 or (208) 799-3020.
